ORDER

The Governor of Haryana is pleased to promote S/Shri Ami Chand Saini, Vinod Kumar and Rajinder Singh as District Revenue Officer in the pay scale of Rs. 15600-39100+6000 grade pay on temporary basis. The promotion of S/Shri Vinod Kumar and Rajinder Singh will be w.e.f. 12.3.2015 i.e. the date of promotion of Sh. Dheeraj Chahal, DRO who is junior to them and the promotion of Shri Ami Chand Saini will be with immediate effect. These promotions will be subject to the following conditions:-

- i) Since the complete ACR record of some officers for the last 10 years is not available as such if at any stage, it is found that they were not eligible for promotion to the post of District Revenue Officer on the basis of those ACRs, they will be liable for reversion forthwith without assigning any reason.
- ii) That the promotion are without prejudice to the claim of S/shri Krishan Lal, Balwan Singh, M.S. Sangwan, Naresh Kumar and Rajinder Kumar Gahlaut, Tehsildars against whom disciplinary action U/R-7 of P&A Rules, 1987 are pending and Shri O.P. Godara whose Annual Confidential Record is not available.
- iii) That their inter-se seniority as District Revenue Officers will be decided in due course.
- iv) The promotion of Shri Ami Chand Saini subject to the condition to the final out come of decision in CWP No. 3071 of 2013 which is admitted in the Hon'ble High Court at present.

The posting orders will be issued lateron.


