**Subject:-** Chandigarh dated the 24-9-15  
**Prior approval of the Government before finalization of compensation/announcement of award in respect of the land under acquisition by Land Acquisition Officers (LAO's).**


Sir/Madam,

I am directed to refer to the instructions dated 14.05.1986 issued vide No. 572-र-3-86/14522 by the Revenue Department which provides for following of certain guidelines by the Land Acquisition Collectors in announcement of awards. Primarily the above instructions provide for approval from Administrative Department concerned for which land has been acquired, before announcement of award of the acquired land.

2. Therefore, in continuation of the above instructions, it is again reiterated that Land Acquisition officers are duty bound to seek prior approval from the administrative department concerned for which land is being acquired before announcement of award. It is, therefore directed that the draft award notification may be got vetted from the concerned Administrative department before announcement of award. In case of land acquisition for Central Government projects i.e. National Highways, Railways etc., draft award notification may be got vetted from these departments i.e. National Highway Authority of India, Railways etc. before announcement of award.

3. Further, it has been decided that in future compensation/ award amount should be transferred in the accounts of land owners whose land is being acquired through RTGS only. The present practice of issuing cheques/ bank drafts and taking signatures of land owners on the receipt slips need to be discontinued forthwith. For this purpose before announcement of the award, Land Acquisition Officers (LAOs) should collect information about the land owners, their names, their bank account number, bank details etc. so that after the announcement of award, amount can be transferred through RTGS instantly.

These instructions should be followed strictly in letter and spirit.




