Subject: In pursuance of quashing of Chief Secretary instructions dated 16-3-2006,  
determination of the deemed dates of promotions to the posts of Deputy  
Superintendents and Superintendents.

The Hon'ble Punjab and Haryana High Court in the Judgment dated  
7-8-2012 in CWP No. 17280/2011 titled as Prem Kumar Verma & others Vs Haryana  
State has quashed the Chief Secretary's instructions dated 16-3-2006 vide which  
Scheduled Castes employees were granted accelerated seniority. In compliance of above  
order dated 7-8-2012, the Haryana Government issued letter No. 22/132/2008-IGSII,  
dated 20-2-2013 and has quashed instructions dated 16-3-2006. Therefore, the seniority  
of Deputy Superintendents and Superintendents is to be revised in the office.

In compliance of above said instructions dated 20-2-2013 the seniority  
and deemed dates of promotion in the cadres of Deputy Superintendents and  
Superintendents was circulated vide this Department Memo under reference, is given  
finality, after considering the objections filed on the following terms and conditions :-

- (i) No recovery will be made from the officials as who have actually worked  
on their respective posts. The officials whose regularization has been  
predated will be entitled to the arrears of pay from the dates of their actual  
promotions on these posts and prior to their actual promotions, the fixation  
of their pay will be treated as a notional one.
- (ii) They can exercise the option for pay fixation within three months from the  
issue of these orders as per the Finance Department instructions No.  
4/3/3003-1 PR(FD), dated 17-01-2011.

Accordingly, final lists of Seniority and deemed dates of promotions in the  
cadre of Deputy Superintendent and Superintendents is enclosed for the information of all  
concerned.
