**In compliance of the judgement dated 16-9-1999 of the Hon'ble
Supreme Court of India in Ajit Singh-II and Haryana Government instructions
circulated vide letter No. 22/73/92-3GSIII, dated 14-10-1999 referred to above,
seniority was fixed in the cadres of Deputy Superintendents, Superintendents and
Under Secretaries vide this Deptt. Memo.No. 8/1/4-Admn.I(I)-2001/221, dated 25-1-
2001 and the deemed dates of promotion in the cadres of Deputy Superintendents,
Superintendents were worked out vide this Department Memo No. 8/1/4-Admn.I(I)-
2001/1180, dated 17-4-2001, No. 8/1/4-Admn.I (I) -2004/ 2860, dated 2-7-2004 and
No. 8/1/4-Admn.I(I)-2006/593, dated 17-2-2006 and the deemed dates of promotion
in the cadre of Under Secretaries were worked out vide this Department Memo No.
8/1/4-Admn.I(I)-2005/2813, dated 6-10-2005, No. 8/1/4-Admn.I (I) -2006/2174, dated
30-6-06 and No. 8/1/4-Admn.I (I)-2008/ 4122-23, dated 17-12-08.**

On the basis of above mentioned judgement and revised seniority Shri Sube Singh Behmani, Under Secretary was reverted to the post of Superintendent vide this Deptt. Memo. No. 1/2/5-Admn.I(I)-2001/245, dated 30-1-2001. S/Shri Amar Singh, Prem Chand and Mehar Chand Premi, Under Secretary were reverted to the post of Superintendent vide this Deptt. Memo. No. 1/2/5-Admn.I(I)-2001/174, dated 24-1-2001. Shri Sube Singh Behmani, Shri Amar Singh and Shri Prem Chand Under Secretaries filed the CWP No. 8727 of 2001 in Hon'ble Punjab and Haryana High Court against their reversion orders and the seniority dated 25-1-2001. Shri Mehar Chand Premi, Under Secretary filed the CWP No. 5387 of 2001 in Hon'ble Punjab and Haryana High Court against his reversion orders and the seniority dated 25-1-2001.

Both the Writ Petitions have been decided by Hon'ble Punjab and Haryana High Court on 21-8-2009 and the Hon'ble Court had passed the following orders:-

“These writ petitions are allowed. Orders dated 24.01.2001 and 30.01.2001 are set aside. The exercise of reversion of the petitioners is quashed and the respondents are directed to re-conduct this exercise in terms of the formulation by Hon'ble the Supreme Court in the case of Sube Singh Bahmani (supra). This exercise is to be completed within four months from the date of receipt of a certified copy of this order and any consequential benefits to which the petitioner(s) may be found entitled as a result of this exercise be further released to them within a period of two months thereafter.

Therefore, in compliance of orders dated 21-8-2009 of Hon'ble High Court the deemed dates of promotion in the cadres of Deputy Superintendents, Superintendents were worked out vide this Department Memo No. 8/1/4-Admn.I(I)-2001/1180, dated 17-4-2001, No. 8/1/4-Admn.I (I) -2004/ 2860, dated 2-7-2004 and No. 8/1/4-Admn.I(I)-2006/593, dated 17-2-2006 and the deemed dates of promotion in the cadre of Under Secretaries were worked out vide this Department Memo No. 8/1/4-Admn.I(I)-2005/2813, dated 6-10-2005, No. 8/1/4-Admn.I (I) -2006/2174 dated 30-6-06 and No. 8/1/4-Admn.I (I) -2008/4122-23, dated 17-12-08 are hereby withdrawn.

Further, in compliance of the judgement dated 16-9-1999 of the Hon'ble Supreme Court of India in Ajit Singh-II, Haryana Government instructions circulated vide letter No. 22/73/92-3GSIII, dated 14-10-1999 and orders dated 21-8-2009 of Hon'ble High Court on the subject referred to above, deemed dates of promotion in the cadre of Deputy Superintendents, Superintendents and Under Secretaries circulated vide this Department Memo under reference is given finality, after considering the objections filed on the following terms and conditions :-

- (i) No recovery will be made from the officers as they have actually worked on their respective posts. The officials whose regularization has been predated will be entitled to the arrears of pay from the dates of their actual promotions on these posts and prior to their actual promotions, the fixation of their pay will be treated as a notional one.
- (ii) This revision of deemed dates will be subject to the final decision of CWP No. 4997 of 2001- Baljit Singh Redhu Vs State, CWP No. 12367 of 2001-Om Prakash Tobaria Vs State and CWP No. 16612 of 2005 – Zile Singh Vs State of Haryana pending in Hon'ble High Court .
- (iii) As the pay scales of employees were revised with effect from 1-1-1996 and 1-1-2006, the officials who desire to exercise their revised option for revision of pay scales are allowed to do so within three months from the date of issue of these lists.
- (iv) The deemed promotion as Under Secretary of S/Shri Umed Singh and Inder Singh Poria (Sr.No. 99, 100) is with effect from 14-10-2003.

Accordingly, final lists of deemed dates of promotions in the cadre of Deputy Superintendents, Superintendents and Under Secretaries are enclosed for the information of all concerned.
